

# **Recent Session Decisions & Registration Information**

On July 22nd the Session met and determined that given the continuing increase in the number of new cases of coronavirus infection in Bluffton and Beaufort County, opening on August 2nd was not in the best interests of the membership. The Session is now looking to October 4th for a possible resumption with a meeting on September 28th to make a final decision.

However, the Session did decide to allow ten "family units", (people living under one roof) to attend live video recording sessions when it is those that are filmed without interruption using the newly acquired video equipment. Those will be at 7pm every other Friday. On alternate weeks, the old method of recording will be used. EVERY Sunday the worship service will be available from 8:30 am and on as usual.

#### Here is the process to register as outlined in the e-blast sent on July 31st:

Our first recording will be 7pm Friday, August 7th, to be viewed on Sunday morning August 9th.

Since attendance is limited, **you must register this Wednesday, August 5th** by calling the church office starting at 9am. We will fill slots on a first come, first serve basis and will also create a waiting list.

If those placed on the waiting list so desire, they will be given the opportunity to be placed on the sign up list for the next service approximately two weeks later. We ask that if those registered find they cannot attend, to please call the church office by noon Friday, so that someone on the waiting list may be given their spot.

All who attend will need to follow the safety protocols set in place; wearing masks, social distancing inside and outside the sanctuary, and refraining from singing.

Out of an abundance of caution and care for all our members, the Session continues to encourage members to stay home and worship online, as we cannot guarantee complete safety.

# Using IRA Funds to Give More to LPC

With the stewardship campaign beginning shortly, I wanted to provide fellow members of LPC with another alternative for giving using pre-tax dollars. If you have saved funds for retirement in an IRA and you are now over 70 years and six months old, you are required to take a mandatory distribution (RMD) from your IRA each calendar year. Funds you withdraw for your personal use require the payment of taxes as ordinary income.

However, if the RMD funds are distributed directly to a 501 (c3) from the financial institution holding the funds, then those funds go to the charity of your choice tax free.

However, because of Covid-19, the Cares act has waived the mandatory distribution for 2020. You may choose to distribute the IRA funds tax free to a non-profit or you may retain the funds in your IRA.

My husband Cal Beltman and I turned 70 and a half in 2017. For the last three years, some of our Required Mandatory Distribution has been given to LPC tax free which has enabled us to increase our level of giving. Please consult your financial advisor before making any decisions because each person's financial situation is different.



#### **Green Team Continued:**

The Congress has followed our church's lead in acting to protect birds against deadly window strikes.

The House of Representatives recently passed legislation which will require future federal buildings to be designed to reduce bird's deaths caused by window collisions. 
Our Congressman, Joe Cunningham, was an early co-sponsor of the legislation which helped move the legislation forward.

Hundreds of millions of birds die each year hitting windows. We perceive an open space in the side of

a building as glass. Birds do not. To them the window reflects whatever is behind them — woods or an open space — and they try to fly through it and are killed. Window collisions are one of the two largest causes of bird deaths. Our bird population has declined 30% since the 1970's - from 13 billion birds to 10 billion birds. One of our members has had three deaths from window strikes. Here is a photo of such a bird which died hitting a front glass door.



Residential windows cause over 40% of those deaths. There are excellent options for protecting against those deaths. Many products advertised on the web, like Window Alert, do not work. # "Following Jesus: Prison Reform"

"[Jesus] unrolled the scroll and found the place where it was written:

'The Spirit of the Lord is upon me,

He has sent me to proclaim release to the captives
and recovery of sight to the blind,

As Christians, we are called to do justice and be merciful. We are to follow Jesus who brings good news to the poor, proclaims release to the captives, and frees the oppressed. The Outreach Ministry believes prison reform is one way we can follow Jesus in our time. We encourage you to learn more about this topic with us as we seek to advocate for just reform.

We hope you will:

#### 1. Learn

- a. A video with Rev. Dion and Rev. Bo Welch, Prison Chaplain, will be available in the coming weeks which will go further in depth about what the problem is, how we ended up here, and why it should matter to us as Christians.
- b. Read "The New Jim Crow: Mass Incarceration in an Age of Colorblindness" by Michelle Alexander (The New Press, 2012)

#### 2. Advocate

a. As we learn more about this together, the Outreach Ministry will provide information on what we can do. This will include contact information for local representatives for you to contact to advocate on this issue in whichever way you feel led. We will also include a draft of a letter to send and what to say when you call in case you find it helpful.

We know much of this is new to many of us, so we encourage you to listen, read, and engage in dialogue with us (even if you disagree!). We want to learn and be challenged, and hope through it all to be faithful disciples of Jesus.


# INVITATION FROM CHRISTIAN EDUCATION AND THOSE READING "THE OTHER WES MOORE" BY WES MOORE



# Change Can Make A Change for August



Some people living in our area do not have medical insurance. To address this need, The **Greater Bluffton Jasper County Volunteers in Medicine** opened its doors in 2011. Today the all-volunteer medical clinic provides medical exams, counseling and nutritional services as well as preventative disease education to over 2,000 eligible uninsured residents. In addition, radiological imaging and lab testing referrals are made for patients needing these services. It takes approximately 75 volunteers to make the day to day operations of the clinic possible. These volunteers include retired physicians, retired nurses and office personnel.

Without primary care for underlying illnesses such as diabetes and hypertension, people of all color are especially vulnerable to challenges like COVID-19. You may have noticed their free COVID-19 Drive-Thru Testing at Bluffton High School on July 22.

BJVIM earned a 2020 Gold Rating from the National Association of Free and Charitable Clinics Quality Standards Program.

If you would like to help with their efforts, please donate by writing a check to LPC and indicate CCMAC-August in the memo section. Other donations they need include office supplies, copy paper, paper towels, soap and gas cards and can be dropped off at their locations in Bluffton and Ridgeland Monday through Thursday after 1:00 p.m. Thanks!

It has been six weeks since we reopened our doors to families experiencing homelessness and we are happy to report that our family of seven is doing really well. Both Mom and Dad are working fulltime, and the kids are thriving in daycare and at The

Boys & Girls' Club in Bluffton. They have also begun exploring housing opportunities nearby and we will be sure to share any updates on their progress.

Additionally, a Mom and her young son have just joined us and are beginning to acclimate to living in the extended-stay hotel, going to daycare, and seeking employment. It is always a transition living in a strange place and being with new people, but we have no doubt that they will both do well.

We are also continuing to provide rental assistance to those whose livelihood has been adversely affected by COVID-19. Some have lost their jobs, while others have had their hours temporarily reduced therefore affecting their ability to pay their rent. Our goal is to assure these families remain housed and do not end up in our Shelter Program.

It is gratifying to be able to support families who are experiencing a traumatic time in their lives and we could not do it without friends like you! If you like to help one of these families, we are still in need of gift cards in small denominations from Walmart and Food Lion. You can drop them off between 8:30 am and 4:30 pm., Monday Friday. Take care of yourselves and those around you!

#### SOME IMPORTANT INFORMATION GOOD TO KNOW...

# How Medicare Beneficiaries Can Fight a Hospital Discharge

Did you know that if you believe that you or your family are being discharged too soon from a hospital that you can file a Medicare appeal and the hospital cannot discharge you until the review is finalized? It will delay the discharge by at least one day, and the hospital cannot charge for your care while the review is in process. We have found that many people are unaware of this process to challenge a discharge, so here is the information. This only pertains to patients who have traditional Medicare, not an HMO/Managed Care product. Each HMO has its own appeals process.

Medicare requires hospitals to give Medicare patients information about their discharge and appeal rights. Within two days of admission to a hospital, the hospital must give the patient a notice called "An Important Message from Medicare about your Rights." This is called the "IM" in most hospitals. If you don't get it, ask for it. You are required to read the notice, sign it, and date it. When you are told you are going to be discharged, if you believe you are being discharged too soon, you can file a "fast appeal". The hospital cannot discharge you or charge you (other than the routine coinsurance and deductible) until the review is complete. The phone number should be on the IM. This will prevent your discharge for at least 24 hours, and if done on a Friday, it will most likely not be decided until Monday, so they must keep you during the weekend. You must file the appeal by midnight of the day you are told you are being discharged.

To file this "fast appeal", call the Beneficiary and Family Centered Care Quality Improvement Organization (BFCC-QIO) assigned to the state where the patient is hospitalized, and they will conduct the review. The number of the review agency for hospitals in SC, GA, NC, FL, and VA is 844-455-8708. You can get more information on the medicare.gov website -> scroll down to 'Claims & Appeals' -> choose 'Your right to a fast appeal' -> choose 'Fast appeals in a hospital'.

When you call the number, you need to have the following patient information:

- Name as it appears on the Medicare traditional ID card (red, white, and blue card)
- Medicare ID number OR Social Security number
- Phone number for them to call back to patient or patient representative.
- A statement explaining the issue. Some examples for challenging a discharge are:

Unsatisfactory discharge plan (e.g., You live alone and need help with at-home care.)

You have stairs in your home and are unable to use them.

You feel too weak to take care of yourself.

You have an infection and/or a fever.

• Name and address of facility including zip code. [See next page for several area hospitals.]
